Quick Install Steps

Important: Before installing the wall clock, verify that an AirTime Transceiver is installed and properly transmitting. You should manually initiate the transmission of the AirTime signal by pressing the TRANS button on the front of your transceiver. If an AirTime transceiver is unavailable, you can still install the clock and set to the current time (see "Setting the Time Manually" on page 7).

- 1. Insert the supplied lithium battery (CR123A) into the battery compartment on the back of the clock.
- 2. Turn the clock on, by sliding the **Power Switch** to the **Start** position.
- 3. Press the **Reset button** on the back of the clock to begin listening for the AirTime correction signal.
- 4. The LED on the front of the clock will flash green every two (2) seconds.
- 5. When the signal is received, the LED will flash green every second and correction will occur. When correction is complete, the LED will stop flashing.

Room Lighting and Battery Usage

The AirTime Solar Wall Clock uses a room's interior lighting for power. Upon initial installation, or for extended periods of low light, the clock will operate accurately using the supplemental CR123A lithium battery (included). Each clock has an innovative light meter feature is to check the light level at the precise installation location.

- 1. Press and hold the Light Meter Button on the back of the clock.
- 2. While holding the button down, position the clock where it will be installed on the wall.
- Look at the LED indicator on the front of the clock to determine the light level (lux).

Average office lighting is between 350 and 500 lux.

LED Indicator	Light Level*	Battery Usage	Battery Life
Green	> 350 lux	N/A	N/A
Red	200 - 350 lux	Yes	~ 4 years
None	< 200 lux	Yes	~ 2 years

* Battery usage and life is based on the lighting level remaining consistent for an average of 8 hours per day.

If the light level is not adequate, you can try moving the clock to a different location in the room or higher position on the same wall closer to the light source. Setting the Time Manually (requires battery be installed)

If the AirTime transceiver is not installed and transmitting, you can manually set the time on the clock and it will operate as a highly precise standalone clock until an AirTime signal is received.

- Press and hold the B button on the back of the clock for 5 seconds, until the red second hand stops.
- Press the A button on the back of the clock to advance the time one minute. You can press and hold the A button to rapidly advance the minute and hour hands.
- 3. When the time on the clock is one minute after the current time, wait until the exact time reaches the second that the second handed stopped and then press the **B button** on the back of the clock.
- 4. The clock will begin normal operation.

- 5. Slide the second clock onto the lip of the double ring assembly and secure using the $3 \# 4 \times 1/4$ " screws at the 3, 6 and 9 O'clock positions.
- 6. Press the Transmit (TRNS) button on the Master and allow the clocks to correct.

Verifying Signal Reception

During normal operation, the clock will listen for the AirTime signal twelve times per day on even hours, at the 58th minute, between the 50th and 59th second. For example, the clock listens between 10:58:50 - 10:58:59 and then between 12:58:50 - 12:58-59, continuing every even hour. The LED will not flash during normal operation. To verify that the clock has properly received an AirTime signal:

- 1. Press the A button the back of the clock
- 2. Look at the LED on the front of the clock
 - a. Green: Signal was received successfully
 - b. Red: Signal was not received.

The LED on the front of the clock will flash Red automatically if the signal is not received within the previous 72 hours.

The AirTime Solar Wall Clock is equipped with an internal power cell that stores energy from the light source. It can take 8 days or more to fully charge the internal cell. With a fully charged cell the clock can run in complete darkness without a supplemental battery for approximately 7 days.

Smart Second™ Energy Saver

The AirTime Solar Wall Clock has an innovative energy saving feature that conserves power at night or when the lights in the room are turned off. When the room lighting is less than 10 lux, the second hand will stop at 0 seconds and the hour and minute hands continue displaying the correct time. When the room lighting rises above 10 lux, the second hand returns to normal smooth sweeping operation indicating the correct second. Average office lighting is between 350 to 500 lux.

Hanging the Clock - Surface Mount

AirTime wall clocks feature an innovative maze style mounting bracket that prevents simple upward motion from removing them from the wall.

- Secure the supplied anchor and mounting screw into the wall leaving the head exposed.
- 2. Slide the clock onto the screw head at the bottom of the maze track.
- 3. Move the clock down, left, down and then right until it rests securely at the top of the bracket.
- 4. To remove the clock, reverse the process above.

Hanging the Clock - Double Mount

The AirTime AT12RPSD is available for wall mount applications.

- 1. Install wall box (Fig. 2, #1)
- 2. Attach box adaptor plate (Fig 2, #2) to wall box with (4) #8-32 x 1" screws (Fig 2, #3).
- 3. Attach the case assembly to couplings with recessed flanged washers (Fig. 2, #4) and chase nipples (Fig. 2, #5). Tighten all components securely.

- 4. Slide one clock onto the lip of the double ring assembly and secure using the 3 #4 x 1/4" screws at the 3, 6 and 9 O'clock positions. (Fig. 2, #6)
 - a. Install 1 CR123A battery in each clock and press the Reset button on each clock.
